10 These dates are set at the direction of the Court after reviewing the Joint
11 Status Report and discovery plan submitted by the parties. All other dates are
12 specified in the Local Civil Rules. If any of the dates identified in this Order
13 or the Local Civil Rules fall on a weekend or federal holiday, the act or event
14 shall be performed on the next business day. These are firm dates that can be
15 changed only by order of the Court, not by agreement of counsel or the parties.
16
17 The Court will alter these dates only upon good cause shown. Failure to
18 complete discovery within the time allowed is not recognized as good cause.

If the trial date assigned to this matter creates an irreconcilable conflict, counsel must notify the Deputy Clerk, Lowell Williams or Laurie Cuaresma by telephone at (206) 370-8521 within 10 days of the date of this Order and must set forth the exact nature of the conflict. A failure to do so will be deemed a waiver. Counsel must be prepared to begin trial on the date scheduled, but it should be understood that trial may have to await completion of other cases.

ALTERATIONS TO ELECTRONIC FILING PROCEDURES

1 As of June 1, 2004, counsel shall be required to electronically file all
2 documents with the court. Pro se litigants may file either electronically or in
3 paper form. Information and procedures for electronic filing can be found on
4 the Western District of Washington's website at
5 <https://www.wawd.uscourts.gov>.

6 The following alterations to the Electronic Filing Procedures apply in all
7 cases pending before Judge Martinez:

- 9 • Section III, Paragraph F: When the aggregate submittal to the Court
10 (i.e., the motion, any declarations and exhibits, the proposed order,
11 and the certification of service) exceeds **50 pages** in length, a paper
12 copy of the documents (3-hole punch, with dividers, banded or clipped
13 as needed. No binders.) must be delivered to the Clerk's Office by 10:30
14 a.m. the day after the filing. The chambers copy must be clearly marked
15 with the words "Courtesy Copy of Electronic Filing for Chambers."
16 • Section III, Paragraph L: Unless the proposed order is stipulated,
17 agreed, or otherwise uncontested, the parties need not email a copy
18 of the order to the judge's orders email address.

PRIVACY POLICY

21 Pursuant to the General Order of the Court regarding Public Access to
22 Electronic Case Files (filed May 29, 2003), parties are to redact the following
23 information from documents and exhibits before they are filed with the court:

- 25 • Dates of Birth – redact to the year of birth
- 26 • Names of Minor Children – redact to the initials

- 1 • Social Security Numbers and Taxpayer-Identification Numbers – redact
2 in their entirety
- 3 • Financial Accounting Information – redact to the last four digits
- 4 • Passport Numbers and Drivers License Numbers – redact in their
5 entirety

6 The General Order was issued pursuant to the official policy on privacy
7 adopted by the Judicial Conference of the United States and can be found on
8 the court's website at <https://www.wawd.uscourts.gov/docs>. All documents
9 filed in the above-captioned matter must comply with the Privacy Policy and
10 the General Order.

11 COOPERATION

12 As required by LCR 37(a), all discovery matters are to be resolved by
13 agreement if possible. Counsel are further directed to cooperate in preparing
14 the final Pretrial Order in the format required by LCR 16.1, except as ordered
15 below.

17 EXHIBITS

18 The original and one copy of the trial exhibits are to be delivered
19 to chambers seven days before the trial date. Each exhibit shall be clearly
20 marked. Exhibit tags are available in the Clerk's Office.

22 The Court hereby alters the LCR 16.1 procedure for numbering exhibits:
23 Plaintiff's exhibits shall be numbered consecutively beginning with the
24 number "1"(one). Defendant's exhibits shall be numbered consecutively
25 beginning with "A-1" (one). Duplicate documents shall not be listed
26 twice. Once a party has identified an exhibit in the Pretrial Order, any party

1 may use it. Each set of exhibits shall be submitted in a three-ring binder with
2 appropriately numbered tabs.

3 **SETTLEMENT**

4 Should this case settle, counsel shall immediately notify Lowell Williams
5 or Laurie Cuaresma, at (206) 370-8521. Pursuant to LCR 3(b), an attorney
6 who fails to give the courtroom deputy prompt notice of settlement may be
7 subject to such sanctions or discipline as the Court deems appropriate.
